#### A RESOLUTION OF THE BOARD OF DIRECTORS OF PROLOGIS CENTRAL PARK BUSINESS CENTER METROPOLITAN DISTRICT CALLING A REGULAR ELECTION FOR DIRECTORS MAY 6, 2025

- A. The term of the office of Director Keiffer Garton shall expire upon the election of his successor at the regular election, to be held on May 6, 2025 ("**Election**"), and upon such successor taking office.
- B. The terms of the offices to which Directors Katie Kier and Relina Dajani have previously been appointed expire upon their re-election, or the election of their successors at the Election, and upon such successors taking office.
  - C. Two vacancies currently exist on the Board of Directors of the District.
- D. In accordance with the provisions of the Special District Act ("Act") and the Uniform Election Code ("Code"), the Election must be conducted to elect two (2) Directors to serve until the next regular election, to occur May 4, 2027, and three (3) Directors to serve until the second regular election, to occur May 8, 2029.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Prologis Central Park Business Center Metropolitan District (the "District") of the City and County of Denver, Colorado:

- 1. <u>Date and Time of Election.</u> The Election shall be held on May 6, 2025, between the hours of 7:00 A.M. and 7:00 P.M. pursuant to and in accordance with the Act, Code, and other applicable laws. At that time, two (2) Directors shall be elected to serve until the next regular election, to occur May 4, 2027, and three (3) Directors shall be elected to serve until the second regular election, to occur May 8, 2029.
- 2. <u>Precinct.</u> The District shall consist of one (I) election precinct for the convenience of the eligible electors of the District.
- 3. <u>Conduct of Election.</u> The Election shall be conducted as an independent mail ballot election in accordance with all relevant provisions of the Code. The Designated Election Official shall have on file, no later than fifty-five (55) days prior to the Election, a plan for conducting the independent mail ballot Election.
- 4. <u>Designated Elec tion Official</u>. David Solin shall be the Designated Election Official and is hereby authorized and directed to proceed with any action necessary or appropriate to effectuate the provisions of this Resolution and of the Act, Code or other applicable laws. The Election shall be conducted in accordance with the Act, Code and other applicable laws. Among other matters, the Designated Election Official shall appoint election judges as necessary, arrange for the required notices of election (either by mail or publication) and printing of ballots, and direct that all other appropriate actions be accomplished.
